LAWFUL PRESENCE IN THE UNITED STATES

Only those students verified to be lawfully present in the United States may be considered for an out-of-state tuition waiver. Waiver applicants may be required to provide additional documentation to meet this requirement. One of the following *must* be submitted:

- A certified US Birth Certificate showing the student was born in the U.S. or a U.S. Territory. (A photocopy or faxed copy is not acceptable)
- A U.S. Certificate of Naturalization (USCIS form N-550 or N-570)
- A U.S. Certificate of Citizenship (USCIS form N-560 or N-561)
- A U.S. Certificate of Birth Abroad issued by the Department of State (DS-1350) or a Consular Report of Birth Abroad (FS-240).
- A current military ID (service member only, not dependent)
- A current, valid permanent resident card (USCIS form I-151 or I-551). Must have copy of the front and back of the card.
- A current U.S. Passport

DOCUMENTATION OF WAIVER ELIGIBILITY

Additional documentation is also required to confirm domicile in the border state such as the following:

- Copy of lease agreement or warranty deed (dated 12+ months)
- Copy of driver's license or state-issued ID
- Copy of vehicle registration
- Copy of state tax return filed for the most recent tax year
- Copy of federal tax return filed for the most recent tax year
- Copy of utility bills
